## Mutton Bustin' Application



Rider Participants must be at least 5 years of age and no more than 7 years of age on the first day of the Rodeo event in which he/she is participating. Rider Participants may not weigh more than 50 pounds. Western attire is required, i.e. boots, long pants, long sleeve shirt, and western hat. Helmets ("IF" not supplied) will also be required (bicycle or similar type is suggested) for the actual ride. The participant and one (1) adult only will be allowed in the chute area. This will be an exhibition event only, not a contest. There is no fee to ride in this exhibition.

**We will fill 6 positions for the Friday, Saturday & Sunday performances. First come, first to participate.**

Applications must be submitted to the Ramona Rodeo by 12 pm PDT, April 30<sup>th</sup>.

The undersigned, being over the age of majority, understands and acknowledges that rodeo events are dangerous activities and that participation in any rodeo event, as either a contestant, employee, volunteer, or other participant, exposes the participant to a substantial and serious risk of personal injury, death or property damage, especially for children. The undersigned also understands and acknowledges that the animals used by Ramona Rodeo Association in rodeo events, have unpredictable behavior. The undersigned expressly acknowledges that participation of his/her child's participation in any rodeo event will involve such hazards.

Mindful of these facts, the undersigned, intending to be legally bound hereby, and in consideration of being allowed to participate, or being allowed to have a child participate, in Ramona Rodeo Association Mutton Bustin', does hereby forever release, on behalf of himself/herself and/or his/her child or children, the Ramona Rodeo, Honeycutt Stock contractors, the Ramona Outdoor Community Center, The Ramona Parks and Recreation Association and The Ramona Municipal Water District, their officers, directors, employees, agents, affiliates and sponsors, from any liability under any and all causes, known or unknown, by reason of any injury, loss, damage, death, or otherwise, which may be suffered by the undersigned or his/her child or children, and hereby assumes and accepts, on behalf of himself/herself and/or his/her child or children, the risk and dangers of injury, pain, suffering, damage, death, or other loss which may occur through or by reason of any matter, thing, condition, negligence, or default. The undersigned agrees to indemnify, hold harmless and defended the Ramona Rodeo, the Honeycutt Rodeo, RMWD, RPR & The Ramona Outdoor Community Center, its officers and directors, members, servants, employees, agents or affiliates, of and from any and all loss, injury, liability or damage arising out of, directly or indirectly, the participation of the undersigned of his/her child or children in the Ramona Rodeo Mutton Bustin'.

This release shall be binding upon the undersigned and the undersigned's spouse, legal representatives, child or children, heirs, successors and assigns, and should any term or other provision of this release be held invalid, illegal or incapable of being enforced due to any rule of law or public policy, all of the other conditions, provisions and paragraphs of this release shall never the less remain in full force and effort. I the undersigned agree to be bound in my individual capacity as a parent or legal guardian for the child or children I enter into and allow to participate in the Ramona Rodeo Mutton Bustin'.

The laws of the State of California will apply in all instances regarding the interpretation and enforceability of this release and this release shall be performed in the County of San Diego, State of California.

The undersigned has full power, authority, capacity, and right without limitations to execute, deliver and perform this complete release, as well as to authorize the child's or children's participation in this event, and the Ramona Rodeo, the Ramona Outdoor Community Center, Inc. is entitled to rely on this presentation.
